The Salmo Valley Swimming Pool hereby grants
(hereinafter called the "Licensee") permission to use the Facilities as outlined, subject to the Terms of Conditions of this Agreement contained herein and attached hereto all of which form part of this Agreement.

The licensee agrees to indemnify and save harmless, the Salmo Valley Swimming Pool and the Salmo Valley Swimming Pool Society from and against all claims and proceedings, by whomever made or brought, in respect to any cost loss, damage, or injury arising directly or indirectly by reason of the use of rental facilities during the term of the lease and any authorized or unauthorized use of the building and facilities by your organization prior to or beyond the terms of this lease.

Admissions Policy:
Salmo Valley Swimming Pool

Children under the age of 10 years old who are non-swimmers must be accompanied by a parent or guardian who is at least 18 years of age and responsible for their direct supervision. The ratio of non-swimmers to parent may be a maximum of 4 bathers to one parent or guardian (4:1). The ratio of non-swimmers to parent or guardian may be increased to a maximum of 8 bathers to one parent or guardian (8:1) if lifejackets are worn by all non-swimmers in their charge.

Children under the age of 10 who are swimmers (able to demonstrate comfort in the water and pass the facility swim test) may be admitted to the swimming pool unaccompanied.

Children under the age of 6 years may not be admitted to the swimming pool unless they are accompanied by a parent or guardian who is responsible for their direct supervision, with a maximum of two children for each parent or guardian.

Guardians or group leaders are responsible for the children in their care while in the facility and must directly supervise the children at all times

Guardians or group leaders should be at least 18 years of age.

The admission policy applies to all open swims and pool rentals. Lifeguards may ask for a demonstration of swimming ability if they feel there is a question of the child's safety.

A limited number of life jackets are available.

Pool Capacity: Salmo Valley swimming pool has a rental capacity for 150 bathers. This number includes both people on the deck and in the water.

Pool Rules:

- Emergency procedures must be observed. Swimmers must leave the pool area immediately upon the signal or request of the lifeguard.
- Food, drinks, and chewing gum are prohibited in the pool area. Plastic bottled water is allowed
- Proper swim attire is required. Cutoffs and street shorts are not permitted.
- No street shoes in the pool area.
- Any behaviour deemed unsafe by the lifeguards is prohibited.
- Use of toys, water wings, floatation devices, masks, fins, snorkels, balls, and any other throwing or diving items are permitted. PFD's are permitted and will be inspected by the lifeguards.
- No front dives, back dives or jumps, twisting jumps, are allowed off the side of the pool.
- No boisterous play.
- Children who are not toilet trained are required to wear swim diapers.
- The Salmo Valley Swimming Pool and its employees are not responsible for lost, stolen or damaged property.
- No person having a communicable disease or open sores on his or her body shall enter the pool.
- Walk; don't run in and around the deck/change rooms.

I have read the rental agreement, fees, admissions policy, definitions and pool rules and agree to abide by all of the above policies taking full responsibility that I have contracted to use. I agree to use the area rented for the time period stated.
